ENGAGEMENT OF CONSULTANT FOR LIBRARY ON CONTRACTUAL BASIS

Indian Institute of Foreign Trade (IIFT) is a premier B-School set up by Government of India engaged in education, training and research in the area of International Business. The Institute intends to engage Consultant for Library purely on contractual basis/re-employment basis, for a period of Six Months. Retired Government servants are also eligible to apply. The candidate should possess the following qualification:

Positions: One post of Consultant for Library

Retired persons who have held analogous posts under the Central Govt./State Govt./Universities/Research Institutions on regular basis and possessing the following educational/other qualification

- a) Holding analogous posts on a regular basis; or
- b) With at least 20 years regular service in the post in the grade pay Rs. 4600/- (pre-revised) or equivalent;

Essential Qualification-

- I. Master's degree in Library Sciences/ Information Science/ Documentation with at least 55% marks or its equivalent grade of B in the UGC seven points scale and consistently good academic record.
- II. At least 10 years as Assistant Librarian in a University/B-School Library.
- III. Evidence of innovative library service and organization of published work.

Age- Age Should not exceed 65 years.

Tenure: The appointment will be purely on contractual basis initially for a period of six months. The tenure could be extended further depending upon the requirement and performance of the selected candidate.

Emoluments: Consolidated remuneration of Rs. 50,000/- to Rs. 60,000/- per month (all inclusive) depending on qualification and experience.

The terms and conditions of contract shall be as under:

- a. The engagement on contract basis will be for six months which may be extended time to time depending upon the performance and requirement of the organization, at the discretion of the competent authority.
- b. Retired Central Government /autonomous bodies/PSUs officers'with requisite QRs as prescribed would be eligible for being engaged on contract basis. The appointment of the officers would be on full time basis and they would not be permitted to take up any other assignment during their engagement.
- c. The contractual engagement shall not confer any right or claim to any regularization or continuance of service. The engagement can be terminated by any party by giving one month's notice in written or consolidated remuneration of one month in lieu.

The selected candidate shall be required to join immediately.
